Several unidentified participants joined the meeting by phone and WebEx.

1. **Call to Order** Len Lindahl, the Team Leader, called the meeting to order. He welcomed all public participants and took a roll call of Team members.
2. **Review of September 22, 2014 Meeting Summary:** No comments.
3. **Status Update by Team Leads and Team Discussion of Near-Term Regulatory Topics:**
 - a. **Per capita:** The Steering Committee's additional table summarizing WMD data collection is being prepared.
 - b. **Water Shortage criteria comparison:** WMD staff continues work to complete the comparison table.
 - c. **Aquifer recharge & impact offset sources and programs:** Complete.
 - d. **Resource redistribution:** Complete.
 - e. **Caution area example review:** Work continues on these tables; information is expected to be presented to the Team at the end of the month.
 - f. **Interdistrict transfer of ground and / or surface water:** Complete.
 - g. **Public interest:** Complete.
 - h. **Conjunctive Use:** Draft is available for Team review.
 - i. **Success Principles:** A questionnaire template was distributed to sub-team members, and a meeting to discuss input to the questionnaires is scheduled for October 31st.
4. **Permitting Thresholds:** A table describing the consumptive use permitting thresholds, by water management district, was distributed to the Team. The table summarizes district action on consumptive use permit applications and was provided as background information concerning regulation of domestic self – supply uses (DSS). In summary, the table lists criteria, such as well diameter and average daily capacity, upon which proposed uses are categorized into General Permit by Rule, Noticed General Permit, and Individual Permit groups for district action. Discussion ensued regarding how DSS uses are accounted for in the CFWI model and potential mapping of actual DSS well locations, particularly in recent years.
5. **Solutions Planning Team Update:** A summary of the meeting was provided.

5. **Regulatory Review of Selected Projects for RWSP:** The draft template was discussed, particularly as to the role of the 8 topics listed above and the scope of Team input. Identification of inconsistencies and impediments to project implementation as well as matters not within the scope of Chapter 373, F.S., were all mentioned. Another draft template will be distributed for Team review and comment prior to the next meeting.
6. **Pending Permit Applications:** No Team discussion occurred.
7. **Open Discussion and Public Comment:** No additional discussion occurred.
6. **Review Schedule for Next Meeting:** The next meeting was re-scheduled to Monday, October 20, 2014 at 3:00 – 4:00 due to conflict with the Steering Committee meeting.
